

Procurement Specialist

The Procurement Specialist in the automotive sector is responsible for sourcing, negotiating, and managing the acquisition of materials, parts, and services that are essential for production and operations. Their main activities include supplier evaluation, contract negotiation, cost analysis, and ensuring compliance with regulatory and sustainability standards. They optimise procurement strategies to balance cost, quality, delivery times, and risk management.

Key responsibilities involve developing sourcing plans, analysing market conditions, managing supplier relationships, and using data-driven tools for supply chain optimisation. They also ensure alignment with corporate sustainability targets by integrating green technologies and monitoring suppliers' environmental performance.

Essential competences include green competences (environmental regulations, sustainable technologies), digital competences (supply chain analytics, use of ERP and procurement platforms), soft skills (negotiation, critical thinking, attention to detail), transversal competences (collaboration, market analysis, procurement systems), and sector-specific knowledge (quality control techniques, vendor management, supplier relationship management).
