

Education Program Designer

The Education Program Designer – Green & Digital Skills develops, pilots, and evaluates training programmes that integrate sustainability and digitalisation into upskilling and reskilling pathways. This professional translates labour market foresight into curricula, coordinates co-creation with multiple stakeholders, and ensures continuous improvement through evaluation and feedback mechanisms.

Main activities include curriculum design, e-learning integration, blended learning delivery, and embedding sustainability themes aligned with SDGs. Responsibilities cover stakeholder coordination, compliance with educational standards, and ensuring curricula respond to evolving digital and green transitions.

Essential competences include green competences (advising on sustainable management, promoting sustainability), digital competences (e-learning, blended learning, CMS use), soft competences (critical thinking, adaptability, networking), and transversal competences (needs analysis, curriculum adherence, programme coordination, stakeholder management). This role enables organisations to respond effectively to the twin transition and supports strategic alignment between education, sustainability, and digital transformation.
